FINANCIAL REPORT: Duane Scott reported the total balance in all the accounts was \$5,346,517.44 at May 17, 2018 compared to \$5,343,633.12 at April 18, 2018. Given the growth of the Foundation it was decided to combine the investment accounts to simplify fund tracking and administration. The fund balances will continue to be tracked individually. The financial report shall be filed. (**Reminder**) The Foundation is now registered with Amazon Smile Foundation. OLD BUSINESS:

- A.) Scholarship Committee Susan Lucas reported she has submitted all the scholarship information to Jeff Moyer.
- B.) Scholarship Administration Donn Ritter reported the transition from Steve Perry to Jeff Moyer is on schedule.
- C.) Grant Committee Donn Ritter presented the 2018 grant recommendations. It was MOVED by Eric Shannon and seconded by Ryan Purkiss to approve the grants: Bethlehem Center, \$15,000; Blanket Ladies, \$5,000; Boys & Girls Clubs of the Sequoias, \$10,000; The Creative Center Foundation, \$15,000; FoodLink of Tulare County, \$25,000; Golden state YMCA, \$10,000; and Visalia Rescue Mission, \$20,000. Motion APPROVED.
- D.) Brewfest 2018 Dru Quesnoy reported Brewfest 2018 is scheduled for August 2nd. All the Foundation and club representatives need to push sponsorships and ticket sales. The week before is competition from another brewfest at the Convention Center. Dru has prepared a variety of handouts to advertise the event and a power point presentation to

use when requesting support from the clubs. Please request volunteers from the clubs to help with busing tables, serving, and clean up duties.

NEW BUSINESS

- A.) Executive Committee Donn Ritter requested any names of prospective officers and directors be given to Shirle or the Executive Committee for the June ballot.
- B.) Respite House –Dru Quesnoy reported Al's House was used 82 days in 2017 and 22 days this year to date; Sharon's House was used 52 days in 2017 and 21 days this year to date. Dru will connect with case managers to determine how to increase the use of the Respite House.
