# VISALIA ROTARY COMMUNITY FOUNDATION MINUTES OF THE MEETING OF THE BOARD OF DIRECTORS

A quorum is 33 1/3% of the nineteen-member voting Board which equals six directors; this meeting had **eleven** votes in the form of **fourteen** directors toward a quorum. A majority vote shall be sufficient to constitute action by the Board of Directors. When a director holds more than one directorship each directorship counts toward a quorum, but the director has only one vote.

**MINUTES**: The minutes of the June 27, 2023, meeting stand as presented.

**FINANCIAL REPORT**: Gary Simmons reported the total balance in all the accounts was \$6,493,502.38 (total assets: \$7,380,725.62) as of July 21, 2023, compared to the balance of \$6,459,658.31 (total assets: \$7,201,006.27) as of June 23, 2023. \$2,500 was disbursed during the month on scholarships.

- A.) Scholarship Committee Jeff Moyer reported five scholarship respondents didn't respond. The committee has nine scholarships ready to be awarded. A brief discussion was held concerning the disposition of unclaimed scholarship funds. It's sad a student who needs a scholarship doesn't receive it. Perhaps there is a way to award unclaimed scholarships to students who don't receive any scholarship funds.
- B.) Grant Committee Donn Ritter reported the grant checks will be distributed and the formal presentations will be divided among the clubs.
