FINANCIAL REPORT: Gary Simmons reported the total balance in all the accounts was \$6,178,614.60 (total assets: \$6,906,715.01) as of October 19, 2023, compared to the balance of \$6,320,219.12 (total assets: \$7,099,135.16) as of September 21, 2023. \$1,000 was disbursed during the month for the Salierno Scholarship. All of the clubs have paid their dues for the year.
